Private Non-Profit (PNP) Schools and Equitable Services:

School districts that receive federal funds are required to provide equitable services for eligible school children, teachers, and other educational personnel at registered private non-profit schools that desire to participate. The term "equitable services" refers to the process of providing students, teachers, staff, and families at eligible PNPs fair access to federally-funded education programs and services as appropriate. Educational services or other benefits, including materials and equipment, provided under this section, shall be secular, neutral, and non-ideological. Among other requirements, the process depends on a "timely and meaningful consultation" between ISD officials and those of eligible PNPs.
